In September, MHDCC hosted representatives from the Maryland Network Against Domestic Violence (MNADV) and area law enforcement agencies for training on the newly updated Lethality Assessment Program.

The Lethality Assessment Program (LAP), created by the MNADV, is an award-winning, nationally recognized practice to prevent intimate partner homicides and serious injuries. Its purpose is to save lives by connecting victims to life-saving, community-based services; hold abusers accountable; and create awareness of lethality factors within victims and communities.

Based on the research of Dr. Jacquelyn Campbell of Johns Hopkins University, MNADV developed the lethality screen and protocol, and implemented the program in 2005.

Law enforcement officers use the lethality assessment to screen and effectively identify victims of intimate partner violence who are at the highest risk of being killed or seriously injured by their intimate partners. Once a high-danger victim has been identified, the first responder asks the victim if they would like to be connected via a hotline call right then to the local domestic violence program for emergency safety planning and services. If yes, the first responder makes the connection on scene.

Merryman House and the Paducah Police Department partnered in 2014 and began using the LAP. Since then, additional law enforcement agencies across the Purchase Region have also partnered with Merryman House and begun to use the screen and protocol in support of this evidence-based practice.

Recently, the LAP was restructured to elevate strangulation as a risk factor for future serious injury or death of victims. The September "2.0" training provided updates on the restructure as well as information on a new database that will allow critical information sharing among agencies while also honoring the confidentiality of survivors. Merryman House staff and representatives from the Paducah Police Department, the Marshall County Sheriff's Office and the Mayfield Police Department attended.

In 2023 alone, our partners connected with us 186 times after survivors' on-scene assessments showed they were at high risk for serious injury or death. We are thankful to each agency partner and officer who takes the time to further listen to survivors' stories, risk factors, and works to connect them with MHDCC services.

And in future news, Dr. Campbell has agreed to provide additional training to our staff and local partners in person in April 2024!

Speaking of support, we held our 9th Annual PaDucky Derby in October! You would think that after eight years, our staff would be over yelling, "Have you adopted your ducks yet?! \$5 to support survivors of domestic violence!" But- we are not, because of how supportive our community members are once they hear about our mission and what the race supports. You make this fundraiser fun for us because of your willingness to support it.

We are pleased to report that the race was supported by more sponsorships than we have EVER HAD! Thank you to the individual families, organizations and businesses that continue to support our race, and to those who jumped on board for the first time ever. This race would not get off the ground without you!

And so, we raced to get 20,000 ducks adopted yet again! While we did not reach our adoption goal, 15,251 ducks were adopted through more than 2,300 sales! When we reflect back to our first races of 6.000 and 8.000 ducks.

we are so grateful that you have helped us raise more and more money to support free services for survivors.

Once those determined ducks took their marks and Paducah Power dropped them into Montgomery Lake at Bob Noble Park, every duck swam its best and fastest race. Three emerged victorious to win cash prizes for their adoptive parents:






