

Our current Strategic Plan, client feedback, board and staff feedback, and community partner feedback all inform our decision-making when it comes to implementing new practices, new positions and other organizational changes. 2024 saw multiple service updates based on what we have learned from our stakeholders!





Danger Assessment Certifications & Becoming the Statewide LAP Provider

In the spring, MHDCC hosted Dr. Jacquelyn Campbell of Johns Hopkins University to train our Advocacy & Resiliency Department and additional staff on using the Danger Assessment. The Danger Assessment is an evidence-based instrument to help determine the level of danger an abused woman has of being killed by her intimate partner.

"Determining someone's level of danger is crucial," said Jayna Burkey, MHDCC's Assistant Director of Advocacy & Resiliency. "The predictors on the Danger Assessment provide a visual aid to survivors of their risk of re-assault and/or lethality – quite literally a picture of the difference in life and death. It will give us the opportunity to have more in-depth safety planning conversations with survivors, and will prompt us to provide any additional resources and referrals each situation requires."

Dr. Campbell developed the assessment to work in conjunction with the Lethality Assessment Program, which is a national, evidence-based practice to prevent intimate partner homicides and serious injuries. MHDCC has used the LAP with law enforcement partners since 2014, and was the first program in Kentucky to implement it. In 2024, MHDCC became the statewide LAP provider.

"Being able to coordinate our response with that of the officers on the scene of a domestic violence incident is invaluable to getting callers out of dangerous situations and connected with our services, safe shelter and wraparound services," said Michelle Gantt, MHDCC's Director of Advocacy & Resiliency.



Legal Advocate for Criminal Court

After conversations and a half-day partnership information exchange with staff from the McCracken County & Commonwealth Attorney's offices in March, MHDCC submitted a request within a grant application for a new position: a Legal Advocate to work primarily with survivors who have cases in criminal court. We received that funding, and our Legal Advocate began in August!

New Client Communication App

As technology advances, so do our efforts to continue to protect survivors. Each time we contact a survivor, we check for safety concerns like if we should use an alias, if we are allowed to identify ourselves as MHDCC staff, or if we are calling during a safe time frame for that individual. So- that means no mass emails, no mass texts, and really no efficient AND safe way to send out important updates.

At the end of 2024, our team was trained on and began to implement a new app we are confident will fully address both the efficiency concerns on our end and the safety concerns of our clients. While we won't be sharing the name of the app with you, we want to keep you informed as we continue to adapt our processes and resources to better serve survivors.

Office Spaces into **Youth Spaces**

Formerly offices in need of repair, these two rooms are now open for our youngest clients to do homework in or simply play.






Now, staff can greet incoming shelter residents and their children with drinks, snacks and the personal care items they need to get started as they complete paperwork in our all-in-one suite





Dining Room / Presentation Space

Our Nutrition Services team serves two hot meals a day, five days a week to our clients in our dining room; our Community Engagement team uses the space for large presentations; and our full staff meetings are held here. Formerly a space with aging lighting, wellloved tables and chairs, and bland features, this completely renovated space is now a bright, welcoming space for families and visitors alike.



Berger Road Makeover & New Sidewalk

After 12+ years of advocacy, the road our Paducah campus is on (Berger Road), was given a makeover! It got a half mile of new curb, resurfaced pavement, and a sidewalk was added! The sidewalk provides a safe path from Lone Oak Road to Merryman House property.

We are so grateful to all who made the project possible: KYTC District 1, Harper Construction, Jim Smith Contracting, the local and state officials and representatives who wrote letters of support, and our local utility partners for relocating utility lines, manholes and power poles.

Our partnership literally paved the way for survivors to safely access our services!

I got my first apartment. It was the best feeling to have a safe place to call home. I still struggled with my addictions because I had not yet found recovery. Over the past two years, I became a Drug Court participant and will be two

Jon became my new housing advocate. Through the last couple years, we have established boundaries and worked on many life-changing events. We meet monthly and work on setting realistic and attainable goals. I recently got a different home in which I am so happy and proud of. Many of the goals were around finding employment, and I now work for [redacted workplace.] I got a car through the Goodwill Opportunity Center's Cars to Work Program. I have made and kept my many different appointments such as dental, eye, medical doctors. Jon and I have worked on budgeting and talked about many financial matters. He is my sounding board every month for whatever I need to talk about.

My life has changed so much. Today, I am a whole person. I found freedom and my independence. I feel safe in my own space. This has only been possible with all the help and support I receive from the Merryman House and the work my housing advocate puts forth for me. I am forever grateful to the whole team at Merryman. I may be a little biased but I feel like I have the best advocate ever! Thank you so much Jon for helping and supporting me along my journey. I truly am a walking miracle and most importantly I am a survivor!!!!

Donna, thank you for sharing your story with us, and with our supporters. Your courage and resilience are inspiring, and we are so proud of all you have accomplished! We know the best is yet to come!

- **OBJECTIVE 6** Increase staffing to meet current needs. *Staffing has increased in some departments, but our current funding is not enough to fully meet this goal.*




